NGOs working in various fields, but particularly women's rights, peacebuilding, arts, and culture were instrumental in opening up the space for local activism. Sonia Alvarez states that NGOs can have a "hybrid character", meaning that some NGOs can be more like grassroots movements, since they direct their resources towards consciousness-raising and mobilization (Alvarez 1999, 189).
